1.	The total number of section of the school shall be restricted to 12 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 10 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken

SI. No.	CONDITIONS FOR COMPLIANCE				
1	The total number of sections shall be restricted to 12. Any further increase shall require prior approval of the Board subject to compliance with affiliation bye laws and availability of rooms of more than 500 ft dimension.				
2	The ramp at the main entrance of the building does not have a hand rail. Even though the school has a large outer campus it has chosen to erect an iron ramp inside the building to access the upper floors. The ramp constructed to access the upper floors is seen as too steep for CWSN to navigate and not as per norms. The school shall affix a hand rail along the ramp at the entrance of the school building and dismantle the iron ramp inside. The school shall construct a ramp/install a lift as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.				
3	The school has converted regular cubicles into CWSN toilets, but they are too small. congested(with a sink) and have no room for a wheelchair/walker to navigate. The school shall make provision for separate toilets for CWSN, boys and girls on every floor, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.				
4	The maths lab is not seen in the video. The school shall breate a maths lab as per SoP of the Board and submit compliance on SARAS within 3 months.

5	As per IC, the ICT connectivity in the computer lab needs to be improved. The library is not well stocked and no separate reading area for staff is seen. The school shall upgrade the computer lab and library as per SoPs of the Board within 3 months and submit compliance on SARAS.			
Failure to submit compliance within the prescribed time shall invite financial penalty against the school.				
7	The school shall conduct training of its teachers with CoE Bhopal within 3 months and submit compliance on SARAS.			
8	The school shall follow the SoPs of the Board for all its labs, library and sports facilities.			
9	The school shall renew all mandatory certificates from time to time.			
10	The school shall not remove the mandatory disclosure section and videography links from its website.
